

Mazuma USA Official Contest Rules and Legal Disclaimer

By entering any Mazuma USA contest, you agree to abide by these official rules and the decisions of Mazuma USA, which are final and binding in all respects.

Contest Eligibility

How to Enter

Eligible participants can enter to win by completing an application. Each participant is allowed 1 entry per company, and an increased number of entries will not increase the likelihood of being selected. Any fraudulent methods of entry or circumvention of the rules may result in Mazuma USA invalidating a participant's entries.

Entries must be original work and not violate anyone's proprietary or intellectual

property rights. Entries that infringe upon the intellectual property rights of others will be disqualified and any claims that arise as a result of infringement will be settled by the participant at their sole expense.

Contest Deadlines

All entries or votes must be submitted on or before midnight EST on the contest dates set forth by Mazuma USA.
